WHAT DOES MONEVO INC DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Credit history and credit scores
- Your contact details and demographic information

How?

All financial companies need to share **customers** personal information to run their everyday business. In the section below, we list the reasons financial companies can share their **customers** personal information; the reasons **Monevo Inc** chooses to share; and whether you can limit this sharing.

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.	
	Our affiliates include companies such as Monevo Ltd.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Non-affiliate share with include financial services companies such as our lender partners, other service providers, and marketing companies	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing partners may include lenders and other third parties that provide services to our consumers in our network.	

Other important information

For California residents: We will not share information we collect about you with nonaffiliated third parties, except as permitted by law, including, for example with your consent or to service your account.

For Vermont residents: We will not share information we collect about you with nonaffiliated third parties, except as permitted by law, including, for example with your consent or to service your account. We will not share information about your creditworthiness with our affiliates other than as permitted by Vermont law, unless you authorize us to make those disclosures.
